CALL FOR ENTRIES

Deadline: June 27, 2008

The Council on Foundations and Grantmakers in Film + Electronic Media (GFEM) are seeking submissions of films and videos for the Council on Foundations' 42nd Annual Film & Video Festival to be held May 4–6 2009, in Atlanta, Georgia.

THE FILM & VIDEO FESTIVAL

The festival showcases films, videos, and television programs that have received support from foundations, corporate giving programs, and donor networks, with the aim of encouraging grant-makers to use media to advance their philanthropic goals. The festival promotes foundation support of creative, high-quality productions that expand the boundaries of the use of media for the social good.

Submissions may target local, state, regional, national, and international audiences. The committee will give special consideration to projects that demonstrate innovative strategies for distribution, outreach, public education, and civic engagement, such as the use of print or broadcast journalism, websites, networking, schools, libraries, or the meetings and conferences of nonprofit organizations.

ELIGIBILITY

To be eligible, projects must have received full or partial funding for either production or distribution from a private, community, operating, or corporate foundation; a corporate giving program; or a donor network. The grantmaker does not have to be a member of the Council or GFEM. The Council will not consider submissions that have been funded solely by public agencies or federal or state grants. The films and videos must have been completed within the past two years. Works may be of any length—from feature length to a brief public service announcement. No works in progress will be considered. **All submission forms, DVDs, and entry fees must be received by June 27.**

SUBMISSION PROCEDURES

Organizations and filmmakers may submit as many film and video projects as they wish. For each submission, the Council must receive the following **by June 27**:

- the submission form, completed online at www.fundfilm.org/call_for_entries/ call_sub_form.cfm. Print a copy of your form before you submit it electronically.
- five printed copies of the submission form, along with five DVD copies of your film.
- a check in the amount of \$60 payable to the Council on Foundations. This fee helps cover a portion of the program's administrative expenses.

DVD submission instructions:

- Do not include more than one project on a single DVD.
- Films in languages other than English must have subtitles or be dubbed. DVDs must be formatted in Region 0 or 1.
- If submitting a film from a multi-part series, submit only one episode, up to 90 minutes, that stands on its own.

Projects may be submitted by filmmakers, project directors, sponsors, or funding sources. If possible, the person or organization submitting the work should provide published reviews of the work, articles about the project or funders, and promotional and outreach materials, such as stills, brochures, press releases, etc.

The Council can only be responsible for the safety of your work while it's in our possession—from the time it arrives at the Council's offices to the time it is returned to you. If damage or loss occurs during this time frame, the Council will compensate you for the DVD(s) lost or damaged. **Please do not submit original materials.**

SELECTION PROCESS

Projects will be reviewed by a program curator and a diverse screening committee consisting of grantmakers, filmmakers, and media users. Approximately 15 films are selected to be in the festival and, of those, 4–5 films are presented with the **Henry Hampton Award for Excellence in Film & Digital Media.** The Henry Hampton Award honors the very best in foundation-funded media, named in honor of a man who broke traditional molds of documentary filmmaking and put excellence and innovation at the forefront of his work.

If your film or video is selected for the festival, it will screen during the Council's Annual Conference, the Fall Conference for Community Foundations, and the Family Foundations Conference. A short clip will also be shown on the Council's Film & Video Festival website at www.fundfilm.org.
